## PROFILE

Robert commenced his legal career as Associate to Justice Hill on the Federal Court of Australia (1990 – 1991). He then worked as a solicitor at Freehills (now Herbert Smith Freehills) between 1992 and 1996 before joining the Bar in 1996. Robert was appointed Senior Counsel in 2009. Robert practises widely in commercial law matters including trials, appeals and arbitrations.

Robert has appeared as Counsel in many leading cases and appeals including landmark cases such as the Firebird/Republic of Nauru proceedings in the High Court (Foreign State Immunity/International Law), the Ha/Walter Hammond proceedings in the High Court (Commonwealth duties of excise and business franchise licence fees), the Roxborough litigation in the Federal and High Court (restitution), the Fostif proceedings (litigation funding and class actions), and more recently, the Banksia proceedings in the Supreme Court of Victoria (administration of justice), the criminal cartel proceedings brought by the Commonwealth DPP against Citigroup and others, and the Toyota class action in the Federal Court.

Currently, class actions, civil penalty proceedings and appeals form a significant part of Robert's practice.
